## **ABSTRACTION OF RESOLUTION**

Ref No. 37/QĐ - HĐQT (for publishing information)

#### **BOARD OF DIRECTORS**

- Pursuant to Laws on enterprise No. 68/2014 / QH13 dated November 26, 2014 and execution instruction documents;
- Pursuant to Regulations on organization and operation issued by Haiphat Investment Joint Stock Company;
- Pursuant to the Minutes of vote Ref. 34/2020/BBKP-HDQT issued by Board of Directors of Haiphat Investment Joint Stock Company (hereinafter called "the Company").

#### **DECIDED:**

**Article 1**. Approve the increasing charter capital at Hai Phat - Binh Thuan One Member Limited Company, as follows:

- Form of capital increase: The owner contributes additional capital in Vietnam dong.
- Time of capital change: August 25, 2020.

**Article 2.** Approve the amendment of the Company Charter of Hai Phat - Binh Thuan One Member Limited Liability Company to be consistent with the changes stated in Article 1 above and the provisions of law.

Specifically: Amending Clause 5.1, Article 5 - Charter capital and increasing or decreasing charter capital

**Article 3.** The Board of Directors assigns and authorizes Mr. Do Quy Hai - The authorized representative to manage the capital of the Company who is also the Chairman of Hai Phat - Binh Thuan One Member Limited Company:

- Representative who are authorized to manage 100% capital contributed to Hai Phat
  Binh Thuan One Member Limited Liability Company (including all the previously and additionally contributed capital) to implement rights and obligations of the Company at Hai Phat - Binh Thuan One Member Limited Company in accordance with the law.
- Organize the implementation of increasing charter capital as required by competent authorities, and accordingly amendment of the Company Charter of Hai Phat - Binh Thuan One Member Limited Company as above - mentioned Articles 1 and 2 in accordance with the law.

**Article 4.** The Resolution comes into effect from the signed date. All members of the Board of Directors, Managing Board, functional division, Hai Phat - Binh Thuan One Member Limited Company and Mr. Do Quy Hai take responsibility to execute this Resolution.
